

Abstrak

Tata kelola organisasi olahraga merupakan seperangkat proses yang diterapkan di dalam suatu organisasi untuk mengarahkan dan mengendalikan kegiatan organisasi guna mencapai tujuan secara efektif dan efisien. Penelitian ini menggunakan metode survei kualitatif dengan metode pengumpulan data wawancara. Instrumen yang digunakan mengadopsi dari (Thompson et al., 2023) dalam penelitian mengenai prinsip tata kelola organisasi berdasarkan beberapa kategori, yaitu, (1) Prinsip berbasis struktur, dengan aspek yang diamati mencakup struktur organisasi dan komposisi pengurus, peraturan/ADART, dan keterlibatan pejabat publik. (2) Prinsip berbasis proses, dengan aspek yang diamati mencakup proses pengambilan keputusan, proses persiapan dan evaluasi kegiatan, dan proses transparansi. (3) Prinsip berbasis hasil, dengan aspek yang diamati mencakup alur koordinasi, komitmen organisasi, dan kesetaraan dalam organisasi. (4) Prinsip berbasis konteks, dengan aspek yang diamati mencakup kegiatan satu periode, permasalahan yang dihadapi, dan merawat anggota/kader. Berdasarkan hasil analisis dan penolahan data dinyatakan bahwa dari ketiga organisasi terdapat kesamaan dan perbedaan dalam berbagai aspek penelitian, perlu adanya peningkatan dan perbaikan tata kelola organisasi olahraga khususnya di Jawa Barat. Tata kelola organisasi yang baik akan meningkatkan kualitas dari organisasi itu sendiri dan harapannya organisasi olahraga di Jawa Barat dapat berkontribusi untuk perkembangan olahraga. Penelitian ini merupakan kebaruan dalam studi analisis prinsip tata kelola organisasi olahraga dengan menggunakan pendekatan empat kategori yaitu berbasis struktur, berbasis proses, berbasis hasil dan berbasis konteks di Indonesia khususnya di Jawa Barat.
