

ABSTRAK

Nuki Arbelia Sutiara Subekti (2005432), Pengaruh *Emotional Intelligence* dan *Risk Perception* terhadap Perilaku *Aggressive Driving* pada Pengemudi di Bandung Raya

Penelitian ini bertujuan untuk menganalisis pengaruh *emotional intelligence* dan *risk perception* terhadap perilaku *aggressive driving* pada pengemudi di Bandung Raya. Penelitian ini menggunakan metode kuantitatif dengan *convenience sampling* yang melibatkan 351 responden. Instrumen yang digunakan dalam penelitian ini meliputi TEIQUE-SF untuk mengukur *emotional intelligence*, instrumen *risk perception* yang diadaptasi oleh peneliti, serta ADBS untuk mengukur perilaku *aggressive driving*. Hasil penelitian menunjukkan terdapat pengaruh negatif yang signifikan antara *emotional intelligence* terhadap perilaku *aggressive driving*, sementara *risk perception* tidak menunjukkan pengaruh terhadap *aggressive driving*. Namun *emotional intelligence* dan *risk perception* secara bersama-sama berpengaruh terhadap *aggressive driving*. Temuan dari penelitian ini mengindikasikan pentingnya kecerdasan emosi untuk mengurangi perilaku agresif dalam mengemudi.

ABSTRACT

Nuki Arbelia Sutiara Subekti (2005432), *The Influence of Emotional Intelligence and Risk Perception on Aggressive Driving Behavior of Drivers in Greater Bandung*

This study aims to analyze the influence of emotional intelligence and risk perception on aggressive driving behavior among drivers in Greater Bandung. The study adopts a quantitative approach with convenience sampling involving 351 respondents. The instruments used include the TEIQue-SF to measure emotional intelligence, a risk perception instrument adapted by the researcher, and ADBS to assess aggressive driving behavior. The findings indicate a significant negative relationship between emotional intelligence and aggressive driving behavior, while risk perception showed no significant impact. However, emotional intelligence and risk perception together influenced aggressive driving. These results highlight the importance of emotional intelligence in reducing aggressive driving behavior.
