CHAPTER III

RESEARCH METHODOLOGY

This chapter deals with research methodology. It explains the method which is used

in this research to find the answer to the research questions. It includes the research

design, data of the research, focus of the research, data collection, data analysis, and

data presentation.

3.1 Research Design

This study is a qualitative descriptive research, which is framed within textual

analysis method. Bogdan and Biden (cited in Sugiono, 2005) state that qualitative

research is descriptive; the data collected are in the form of words or pictures rather

than number.

In addition, Nazir (1988) defines a qualitative method as the investigation on

a group status, an object, a set of condition, a paradigm or sequence of a current

event. It is aimed at providing an accurate factual and systematic description on facts,

natures and relation of research phenomenon. Moreover, Alwasilah (2002) mentions

that qualitative research principle emphasizes that every (temporary) finding is based

on data, therefore findings are becoming more valid before stated as a theory.

In the research, the qualitative method is chosen because the writer believes

that this design is the most appropriate method to conduct this study in relation to the

ideology of ideological state apparatus related to physical appearance. As Miles and

Huberman (1987) state that:

Qualitative data is in the form of words rather than numbers; they are attractive and source of well-grounded, rich descriptions and explanations of processes occurring in local contexts. With qualitative data one can preserve chronological flow, assess local causality, and derive

fruitful explanations

The qualitative method is able to describe the data about the ideology of ISA

(Ideological State Apparatus), in constructing the concept of beauty in the novel in

more detail because of its capability in obtaining rich explanations. Based on the

explanation, the qualitative descriptive research is suitable for the study, because this

research needs a lot of description in explaining the data.

3.2 The Data of the Research

The data of the study were taken from a novel entitled *Uglies* written by Scott

Westerfeld. The novel was firstly published in 2005, written in English and consists

of three main parts and 50 chapters. The data were analyzed using the theories on

ideology perspective including from Louis Althusser (1971) and Karl Marx (1845).

The writer also used the theory of power relation by Marilyn French (1985) to see the

ideology in a wider perspective.

3.2.1 The Synopsis of *Uglies*

Uglies as a young adult literature tells about life of Tally Youngblood, a 15

years old girl who is dreaming of becoming pretty, like all of her friends in their

upcoming 16th birthday. Tally always believes that the only way to become pretty is

through operation, until she meets Shay. Shay persuades Tally to abandon the

operation and follow her to runaway to the Smoke (a place where people refuse to

take an operation). Shay's runaway causes Tally into trouble. Tally has to face the

special circumstances which force her to find Shay, unless she decides not to have

the operation. The journey in finding the *Smoke* and Shay changes Tally's life. Tally

is no longer a town girl who only dreams of operation and becoming pretty, she finds

out that there is something wrong with the operation, something that makes people

blind to see reality.

3.3 Focus of the Research

The study is limited on the ideological analysis of *Uglies*. The main issue

analyzed in the study is the ideology of the state apparatus, based on Althusser (1971)

and Marxist (1845) theory. The study focuses on investigating the manifestation of

Ideological State Apparatus in operating their ideologies to the society through power

that they have.

With the breadth issue on ideology, the writer formulated the research questions

to accomplish the objective of the study. The research questions are:

1. In what ways "ISA" is manifested in the construction of pretty and ugly?

2. In what ways does "ISA" operate in *Uglies*?

3.4 Data Collection and Data Analysis

The data analysis of the study is conducted through several stages. The first stage

was reading and rereading the novel thoroughly to get thorough understanding about

the issues in the novel. The second stage was identifying the textual evidence from

the novel. The third stage was categorizing the identification that has been made,

while the fourth stage was categorizing contradiction that happened to its main

character which is Tally Youngblood. The fifth stage, then, was discussing and

interpreting the analysis mentioned in the previous stages and answering the research

questions. Finally, the analysis was ended with conclusions and suggestions for a

further research.

3.4.1 Steps of Analysis

In this research, the data was collected from Uglies, a novel written by Scott

Westerfeld. The study was conducted through the following steps:

1. Reading and re-reading the novel thoroughly to get the deeper

understanding of issues in the story, especially about the ideologies of the

main character on the conception of prettiness.

- Finding textual evidence from the novel which is related to the ideologies of state apparatus on the conception of prettiness that construct the main character ideologies.
- 3. Finding and reading other sources related to the study to form the theoretical framework.
- 4. Classifying the data based on the categorization that has been made on the category of state apparatus, focusing on the ideologies that exist in the story of *Uglies*.
- 5. Analyzing and interpreting the data based on the theoretical framework on ideological state apparatus ideology as the perspective proposed by Marx and Althusser.
- 6. Making conclusion of the study.

3.5 Data Presentation

To accomplish data analysis, the presentation of the data is formulated in a form of the table, to answer research questions. The table is made as follows:
