CHAPTER III

RESEARCH PROCEDURE AND DATA PRESENTATION

3.1 Introduction

This chapter describes the study in more detail and also presents the data that will be discussed on the next chapter. The writer will highlight the most significant aspects of the study, among others, data collections, elaboration of analysis procedure and data interpretation.

3.2 Research Question

This study attempts to find the answers to the question how violence is constructed in some selected songs from Snoop Dogg's "The Best of Snoop Dogg" compilation album.

3.3 Research Procedure

3.3.1 The Context of the Study

This study is a literary-work analysis of song lyrics and video clips. As mentioned in the previous chapter, this study aims at examining the violence and how it is constructed in the lyrics and video clips through two levels of text structure: Macrostructure and Superstructure. Popular Culture theory will also frame the presentation of violence in the discussions.

Snoop Dogg's "The Best of Snoop Dogg" compilation album was chosen considering its theme and its potentials to be explored, i.e. violence. The theme of complex social issues such as violence characterizes Snoop Dogg's lyrics and video clips. According to the article in TIME magazine, September 28, 2007, "the lyrics and

video clips often caused controversial matters, such as woman-hating, N-word (nigga) spouting, sexual abusing towards women (bitches), showing pornographic scenes, etc." Controversies in the lyrics and video clips are interesting to be explored, since those phenomena are still echoed in the life of peoples living in America, especially African American people.

3.3.2 Data Collection and Data Analysis

After reading and observing the text thoroughly, some textual and visual evidence or indicators of violence were chosen. Then, those evidence or indicators were categorized into elements of violence which would be very important in representing the construction of violence in the song. This first level of analysis was projected onto a wider social context, using the Popular Culture theory to explain the construction of violence in Snoop Dogg's songs.

3.4 Data Presentation

3.4.1 Selected Songs from Snoop Dogg

The data of the present study are Snoop Dogg's selected songs from his latest Compilation Album "The Best of Snoop Dogg". These songs are taken from Snoop Dogg's bestseller albums. These three songs are chosen because each of them is the most controversial song – in lyrics, video clips and stories behind the song - from each released albums. Those three songs are nominated in many awards and also win several awards and Platinums. Here are the descriptions of Snoop Dogg's selected songs.

3.4.3 The Textual-Evidence of the Elements of Violence which Appeared in Snoop Dogg's Selected Songs (Schema in Superstructure Level)

The followings are the textual-evidence presented according to Van Dijk's Schema at the superstructure level of text. The representations are presented in the form of a table, which mainly aims at making data more manageable.

3.4.3.1 The Textual-Evidence of the Elements of Violence in Snoop Dogg's "Gin & Juice".

Based on schema in Superstructure level, there were some elements and indicators of violence that can be concluded from the song lyric and video clip of 'Gin & Juice'.

In the Lyric

1. The use of vocatives that have negative meaning and are considered rude.

- 2. Showing implicit and explicit sexual behavior
- 3. Objectifying women, by using them only as an object of sexual activities and totally didn't respect women. Subordinating women by saying 'not with cherry on top' which means that women were viewed as edibles.
- 4. Mentioning sexual devices implicitly, such as 'bubblegum' or 'pocket full of rubbers'.
- 5. The use of words that were derogatory, such as 'motherfucker', 'funky ass shit', 'fucked up', etc.
- 6. Mentioning his hometown, Long Beach, California or usually called as 'LBC' and also telling stories about his life in the streets, emphasizing that his music was really influential on the listeners.
- 7. Neglecting orders and norms, such as having party until morning when his parents were not at home and drinking on the street in front of public, doing disturbing actions.
- 8. Partying,
- 9. Smoking,

- 10. Drinking and mentioning the brands of alcoholic drink,
- 11. Showing that money was all that he cared about.

In the Video Clip

- 1. Neglecting orders and norms, by showing his daily life in a very negative manner. For example, ignoring his parents when talking about something important like finding a job and having a party until morning when his parents weren't at home.
- 2. Showing lack of responsibility towards himself and others.
- 3. Showing explicit and implicit sexual scenes
- 4. Objectifying women and showing no respect towards women.
- 5. Partying scene
- 6. Sensual dancing scene
- 7. Explicit and implicit drinking scene
- 8. Gambling
- 9. Ignorant of surrounding and destructive

3.4.3.2 The Textual-Evidence of the Elements of Violence in Snoop Dogg's "Murder was the Case".

Based on the schema in Superstructure level, there were some elements and indicators of violence that can be concluded from the song lyric and video clip of 'Murder was the Case'.

In the Lyric

1. The use of vocatives that have a negative meaning and are considered rude.

- 4. The use of guns or weapons
- 5. The use of words that have a negative meaning and very rude to intimidate people, such as, 'fuck' and 'damn'
- 6. Regretting what he had done
- 7. Feeling weak and unconscious
- 8. Hallucinating because of being unconscious
- 9. Being accused with a murder case
- 10. Showing the effect of intimidation activity towards himself and people that care for him
- 11. Wasting money
- 12. Mentioning expensive and luxurious things, such as, 'a Benz', 'a Jag', 'a ninetrizzay El Do-Rad', etc

- 13. Smoking
- 14. Mentioning illicit drug and brands of alcoholic drink
- 15. Mentioning his hometown, Long Beach, California or usually called as 'LBC' and also telling stories about his hard life, being arrested and taken to a prison, being intimidated by other prisoner and also by the guards, etc.
- 16. Snoop slightly mentioning his name and his style in the lyric
- 17. Neglecting orders by keeping weapons in prison's sells, doing disturbing activities, etc

In the Video Clip

- 1. Showing and assuring that Snoop is really a famous entertainer and every single thing that happened to him is highlighted.
- 2. Implicit and explicit intimidation and harming activity using guns
- 3. Feeling weak and unconscious
- 4. Showing the effect of intimidation and harming activity
- 5. Hallucinate meeting a 'demon' or perhaps 'God' because of being unconscious
- 6. Showing a copious accident
- 7. Showing expensive and luxurious things, such as, luxurious cars, huge house, etc
- 8. Sensual partying scene
- 9. Drinking scene
- 10. Objectifying women and showing no respect towards women
- 11. Smoking scene
- 12. Being arrested and taken to prison
- 13. Showing the effect of neglecting orders and norms

- 14. Showing a distinction in the way of treating prisoners
- 15. Psychological abuse

3.4.3.3 The Textual-Evidence of the Elements of Violence in Snoop Dogg's "Drop It like It's Hot".

Based on the schema in Superstructure level, there were some elements and indicators of violence that can be concluded from the song lyric and video clip of 'Drop It Like It's Hot'.

In the Lyric

1. The use vocatives that have a negative meaning and are considered rude.

- 6. Mentioning expensive and luxurious things
- 7. Subordinating other people by saying that his boat is more precious and more expensive that foods eaten by other people
- 8. Giving influence of his lifestyle to younger people
- 9. Disseminating a cunning way of how to get famous and wealthy through intimidating someone
- 10. Intimidating, harming and threatening activity
- 11. The use of Snoop's special characteristics in saying something with an extra 'izz' or 'izzle' in the middle of words such as 'ahhizzead' to say 'ahead'.
- 12. The use of words that are very rude and seems like to have a negative meaning or even do not have any meaning at all, such as 'shit', 'fuck', etc.
- 13. Assuring that he's a boss of 'gangstas' and also mentioning his name which is also assuring that everybody knows him.
- 14. Showing implicit and explicit sexual behavior
- 15. Objectifying women and showing no respect towards women
- 16. Showing useless activities, such as 'hang out'
- 17. Showing the effect of intimidation and neglecting orders
- 18. Feeling satisfied of other people's difficulties or troubles

In the Video Clip

- Showing some characteristics of Hip-Hop culture, such as, make Graffiti on the wall and wearing 'blink-blink' jewelries.
- 2. Showing acronyms that are only known by Snoop and perhaps other Hip-Hoppers, such as LBC (Long Beach, California) and DPG (Dogg Pound Gang).

- 3. Objectifying women
- 4. Implicit drinking scene
- Showing a trademark logo of a fashion company that is usually worn by Hip-Hoppers
- 6. Showing expensive and luxurious things
- 7. Implicit and explicit smoking scene
- 8. Gambling to win a big amount of money and becoming a big boss
- 9. Showing pornographic scene
- 10. Showing explicit sexual behavior
